

# Official Rules

## "Children's Museum Family 4 Pack" Facebook Like & Share Sweepstakes

**NO PURCHASE NECESSARY.  
PURCHASE WILL NOT IMPROVE CHANCES OF WINNING**

1. **When to Enter:** You may enter "Children's Museum Family 4 Pack" Like & Share Sweepstakes ("Sweepstakes") from 9:00 AM Central Time ("CT") on 10/20/17 for the first post, 9:00 AM Central Time ("CT") on 10/23/17 for the second post, and 9:00 AM Central Time ("CT") on 10/25/17 for the third post through 11:59:59 PM CT on 10/22/17 for the first post, 11:59:59 PM CT on 10/24/17 for the second post, and 11:59:59 PM CT on 10/24/17 for the third post.
2. **How to Enter:** To enter, visit the ABC 6 News – KAAL TV page on Facebook ("Website") during each Sweepstakes Period, **like AND share** on the "Children's Museum Family 4 Pack" post by answering the question posted in the post to receive one (1) automatic entry into the Random Drawing. You must both "like" and post a Like & Share on the post in order to receive an entry.

All answers/Like & Shares/likes must be posted by 11:59:59 PM CT on 10/22/17 for the first post, 11:59:59 PM CT on 10/24/17 for the second post, and 11:59:59 PM CT on 10/24/17 for the third post to be entered into each Random Drawing. **Limit:** one (1) entry per person/email address. Anyone attempting to get more than one (1) entry may be disqualified from the entire Sweepstakes at Sponsor's sole discretion.

Sponsor will make up to **2 attempts** to contact the winner.
