The Complainant, being duly sworn, makes complaint to the above-named Court and states that there is probable cause to believe that the Defendant committed the following offense(s):

### COUNT I

Charge: Prostitution - Hires/offers/agree to hire; individual believes under age 14; penetration or contact

Minnesota Statute: 609.324 subd. 1(a)(3), with reference to: 609.324

subd. 1(a)

Maximum Sentence: 20 years in prison and/or \$40,000 fine

Offense Level: Felony

Offense Date (on or about): 11/1/2023 to 11/2/2023

Charge Description: On or about 11/1/2023 to 11/2/2023, within the County of Olmsted, the defendant did hire or offer or agree to hire an individual who the actor reasonably believes to be under the age of 14 years to engage in sexual penetration or sexual contact.

Charge: Solicit Child or Believe to be a Child Through Electronic Communication to Engage in Sexual Conduct

Charge Description: On or about 11/1/2023 to 11/2/2023, within the County of Olmsted, the defendant used the Internet, a computer, computer program, computer network, computer system, an electronic communications system, or a telecommunications, wire, or radio communications system, or other electronic device capable of electronic data storage or transmission to solicit a child or someone the defendant reasonably believes is a child to engage in sexual conduct, with the intent to arouse the sexual desire of any person.

Charge: Engage in Electronic Communication Relating or Describing

Sexual Conduct with Child.

Charge Description: On or about 11/1/2023 to 11/2/2023, within the County of Olmsted, the defendant used the Internet, a computer, computer program, computer network, computer system, an electronic communications system, or a telecommunications, wire, or radio communications system, or other electronic device capable of electronic data storage or transmission to engage in communication with a child or someone the defendant reasonably believes is a child, relating to or describing sexual conduct.



### STATEMENT OF PROBABLE CAUSE

On November 1, 2023, the Rochester Police Department and the Minnesota Bureau of Criminal Apprehension (BCA) were conducting an investigation into individuals who utilize the internet to sexually exploit children. On November 1, 2023, an undercover detective from the Rochester Police Department ("UC Detective"), who was using the online persona of a 13 year old girl, received a chat message from an individual, later identified as MATHEW RICHARD ADAMSON, DOB/122178, the defendant herein.

On that day, the UC Detective and the defendant engaged in an online conversation. The conversation began with the defendant requesting the age and gender of the UC Detective. The UC Detective immediately responded with information clearly indicating that they were a 13 year old female. The defendant continued to communicate with the UC Detective and stated that he would purchase alcohol, specifically White Claw, in exchange for various sex acts including oral sex, masturbation, and fondling her breasts. The online conversation between the defendant and the UC Detective continued into November 2, 2023. The stated age of the UC Detective (13 years old) was provided multiple times during the online communication.

While the defendant engaged in online communication with the UC Detective, the defendant initiated a second online conversation with an undercover Special Agent with the MN BCA. At the time, the Special Agent was using an online persona of a 14 year old girl. The defendant sent a picture of his face to the Special Agent as well as a photograph of his work boots. The background in the photograph appears to be an Olmsted County courtroom. The defendant asked the Special Agent if she would ever be comfortable meeting in person. The online conversation with the Special Agent occurred at the same time the UC Detective was communicating with the defendant.

During the conversation with the UC Detective, the defendant requested the UC Detective, who he knew or believed to be 13 years old, to meet him in person at a specified location in the City of Rochester, County of Olmsted. On November 2, 2023, at approximately 6:30 p.m., law enforcement surveilled the defendant leaving his employment from the Olmsted County Work Release Center and observed the defendant drive to the agreed upon meeting location. At the location, the defendant made contact with a decoy set up by law enforcement. The defendant called out to the decoy using the UC Detective's online persona name which was provided to the defendant during their online communication. Law enforcement officers moved in and placed the defendant under arrest.

NOTICE: You are hereby notified that failure to appear for court when required to do so is a criminal offense in the State of Minnesota, pursuant to Minn. Stat. sec. 609.49. If you are charged with or have been convicted of a felony offense, an intentional failure to appear for a court appearance is a felony offense, which is punishable by one-half of the statutory maximum term of imprisonment or fine, for the underlying crime for which you fail to appear, and is to be no less than one (1) year and one (1) day in prison, and/or a \$1,500 fine, pursuant to Minn. Stat. sec. 609.49, Subd. 1(a). If you are charged with a gross misdemeanor or misdemeanor offense, an intentional failure to appear for trial is a misdemeanor offense and may be punished by imprisonment of up to ninety (90) days in jail and/or a \$1,000 fine, pursuant to Minn. Stat. sec. 609.49, Subd. 1.

Complainant requests that Defendant, subject to bail or conditions of release, be: Arrested or other lawful steps be taken to obtain Defendant's appearance in court; or

Detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.

Complainant declares under penalty of perjury that everything stated in this document is true and correct. Minn. Stat. Sec. 358.116; Minn. R. Crim. P. 2.01, subds. 1, 2.
